

Life Christian Daycamp

Parents: Please read carefully, initial beside each one, and sign at the bottom. Please let us know if you have any questions! Thank you.

Registration fee of \$50.00 and the first week's tuition is due upon enrolling and are non-refundable. _____

Our facility does not open until 6:00a.m; please do not bring your child into the building until 6:00 a.m. We need time for our staff to prepare for the day. _____

Part-time Campers must decide which day/s you choose and those will be your days for the summer. You will be charged the **\$50 daily rate**. Your camper whether they attend or not will be charged for that week. _____

Full-time Camper: There is a weekly fee of \$110.00. When signing up for full time you are agreeing to have your campers here all summer. You will be responsible for all 10 weeks of the camp. _____

Your account with us must stay current. You will need to secure your account with a Credit/Debit Card. Weekly payments must be made on Wednesday for the following week. If no payment has been made by Friday, a \$5.00 late fee will be added or if your card is declined, a \$5.00 insufficient fee will be added. If no payment has been made by Friday, your child may not return to daycamp until payment has been made. Your account must stay one week ahead. Your child will be dropped from daycamp if account does not stay current. A reinstatement fee of \$20.00 will be added for any child dropped from daycamp. Please keep in mind that if your child is dropped from daycamp, your spot can be filled with children on our waiting list. This payment method keeps you always a week ahead; you are paying for the next weeks care. If you ever have any questions about your account, please contact the finance office at #390-5081 _____

The daycamp is open from 6:00 a.m. to 6:00 p.m. Late fees of \$1.00 per minute will be assessed for each child staying after 6:00 p.m. Please keep in mind that this goes by our clock here at the school; please adjust your clocks accordingly. _____

For the benefit of all the children, we cannot accept a child with fever, diarrhea, severe sore throat, vomiting, constant coughing, heavy nasal discharge, pink eye, head lice, any contagious diseases, or rash. If your child has any one of these symptoms, your child may not come to daycamp for a 24 hour period unless you have a release from your doctor. Please keep in mind that if your child comes to daycamp with any of these symptoms, we will call you immediately to come and pick up your child. If your child develops any of the above symptoms while at daycamp, we will notify you immediately and you will be required to pick them up immediately.

One week of vacation can be taken during our 10 week camp session. You are not required to pay for this week; however, you are required to take vacations from Monday to Friday only. You may not split the week up for example from Wednesday of one week to Tuesday of the next week. You must call and notify the office that you will be using a vacation week. If you do not call, you will be billed your full weeks tuition. _____

I understand that if Life Christian daycamp calls to pick my child up due to illness, I have 45 minutes from the time called or a late fee of \$1.00 per minute will apply. _____

I understand that Life Christian Daycamp may call me to discipline my child here or pick up my child due to discipline problems that occurred while in Daycamp. **Reoccurring discipline problems may be a cause for dismissal from the program.** _____

I understand that if my status changes at any time, I must notify the office immediately. This means changes in work #, home #, cellular #, custody status, marital status, or changes of who can pick up your child. We must be able to notify you at all times. _____

I understand that all medicine must be signed in on the medicine sign-in sheet located on the check-in table, and then handed to a daycamp worker. I understand that I may not put it in their backpack. We cannot have any medicine anywhere but in the medicine/first aid kit that is taken with them at all times; this is a state guideline. _____

I understand that I am responsible to keep my child's shot record updated. We are required to keep current immunizations and must have an updated copy in the office. _____

I understand that Life Christian closes on certain holidays. I understand that I am still required to pay the full week price when these days occur. Part-time students may not switch days even when holidays occur unless there is space available and is cleared with the office. You will not be able to switch for any other reason. _____
